

CONTRACT FOR INDOOR EXHIBIT SPACE

2023 Seward County Fair

The Seward County Agricultural Society hereby agrees to provide Indoor exhibit space to:

On the following dates: August 10th, 11th, 12th, and 13th(Thursday, Friday, Saturday, & Sunday), 2023. The rental fee for the aforementioned dates is:

County Resident: \$80.00 Non-County Resident: \$125.00

The booth spaces and the electricity is provided. Terms of this agreement are as follows:

1. Each exhibitor will provide their own materials. However, a six foot table and chairs will be provided along with an electrical plug-in, booth sides, and background. The booths are 8 ft. X 8 ft.
2. All decorative materials must be fireproof to meet the Fire Marshals requirements.
3. Exhibit building will be open to the public at 5:00 p.m. on August 10th and will remain open until 9:00 p.m. Friday and Saturday hours are 11:00 am until 9:00 p.m. On August 13th, the building will open at 12:00 p.m. and remain open until 4:00 p.m. All exhibitors are asked to leave their booths intact until that time.
4. Access to the building for set-up will be available 12:00 (noon) on Wednesday, August 9th, and Thursday morning August 10th, at 8:00 a.m. All other arrangements must be cleared by Mike Flyr or Ginny Koranda. Set-up should be completed by 4:00 p.m. on Thursday, August 10th. No exhibit will "tear down" or be released prior to 1:00 p.m. on Sunday, August 13th.
5. All contract signers acknowledge that fairgrounds area is in a flood plain and no damages due to water or extenuating perils will be the responsibility of the Seward County Agricultural Society.
6. Prior space reservations will not be honored after July 1, 2023, without a signed paid contract.
7. ALL VENDORS MUST PROVIDE PROOF OF LIABILITY INSURANCE COVERAGE, DESIGNATING SEWARD COUNTY FAIR DATES WITH THE RETURNED CONTRACT.
