

**CONTRACT FOR OUTDOOR FOOD VENDOR SPACE**

**2023 Seward County Fair**

The Seward County Agricultural Society hereby agrees to provide outdoor exhibit space to:

On the following dates: August 10<sup>th</sup>, 11<sup>th</sup>, 12<sup>th</sup>, and 13<sup>th</sup> (Thursday, Friday, Saturday, & Sunday), 2023.

**ALL FOOD STANDS WILL BE CHARGED 10% OF GROSS INCOME.** Payment is due at the conclusion of the fair!

1. Each exhibitor will provide their own materials. An electrical plug-in is provided. A spot will be designated.
2. Exhibits can be set up no earlier than noon on Wednesday, August 9th, but must be in place by 4:00 p.m. on Thursday August 10<sup>th</sup>. All other arrangements must be cleared by Doug Brand or Mike Flyr, as designated spots are assigned.
3. The exhibit will be open to public traffic anytime after set-up; but no later than 5:00 p.m on August 10<sup>th</sup>.
4. No exhibitor will "tear down" or be released prior to 5:00 p.m. on Sunday, August 7<sup>th</sup>.
5. ALL SPACE RESERVATIONS MUST BE MADE BY **JULY 1, 2023**.
6. All contract signers acknowledge that fairgrounds area is in a flood plain and no damages due to water or extenuating perils will be the responsibility of the Seward County Agricultural Society.
7. Non-local food booths must settle up prior to leaving the fairgrounds. Please contact Doug Brand or Mike Flyr
8. ALL EXHIBITORS MUST PROVIDE PROOF OF LIABILITY INSURANCE COVERAGE, DESIGNATING SEWARD COUNTY FAIR DATES WITH THE RETURNED CONTRACT.
